

COMPEER FINANCIAL PATRONAGE DIRECT DEPOSIT DONATION CONTEST TERMS & CONDITIONS

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS GIVEAWAY. PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING.

ELIGIBILITY: The Giveaway is open only to persons who and entities which are customers of Compeer Financial, ACA and/or its subsidiary entities Compeer Financial, FLCA and Compeer Financial, PCA (collectively, "Compeer") and are eligible to receive patronage payments on account of their ownership interest in Compeer. Officers, directors, managers and employees (including immediate family members (spouse, parent, child, sibling and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of Compeer and each of their respective divisions, affiliates and related companies, licensees, distributors, retailers, dealers, printers, advertising and promotion agencies, consultants and agents, and any others engaged in the development, production, execution or distribution of this Giveaway are not eligible to participate or win a prize. Giveaway is subject to all federal, state and local laws and regulations.

HOW TO ENTER: By completing the required portions of the Patronage Direct Deposit Authorization form, entrants will automatically be entered in the contest. The form must be submitted via MyCompeer, via a secure digital signature form provided by a local office, or via a physical form completed and submitted to a local Compeer Financial branch. In order for an entry to be valid, the Entrant must have a valid e-mail address.

Limit of one (1) entry per client patronage enrollment (i.e. primary account holder). Entrant must complete and submit all required information to be eligible to enter. Entries having incomplete information will be disqualified and ineligible to win.

Compeer is not responsible for any entry that is late, misdirected or undeliverable, due to system errors, omissions, interruption, deletions, defects, delay in operations or transmissions, theft or destruction or failures, faulty transmissions or other telecommunications malfunctions, entries not received resulting from any hardware or software failures of any kind, lost or unavailable network connections, failed, incomplete or garbled computer or telephone transmissions, typographical or system errors and failures, faulty transmissions, technical malfunctions, or otherwise.

In the event of a dispute regarding the identity of the person or entity submitting an entry, the entry will be deemed submitted by the authorized account holder of the e-mail address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the e-mail address by an Internet access provider, on-line service provider, or other

organization that is responsible for assigning e-mail addresses, or the domain associated with the submitted e-mail address. Potential Winner(s) may be required to show proof of being the authorized account holder.

Any attempt by an Entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations, and/or any other methods, including, but not limited to, automated entry, will void that Entrant's entries and that Entrant may be disqualified from the Giveaway. Multiple Entrants are not permitted to share the same email address. Neither the Compeer nor Giveaway Administrator will verify receipt of entries for Entrants. All entries submitted become the sole property of Compeer and will not be returned.

PRIZES: Two (2) donations shall be awarded: The first via a random drawing of all the eligible entries received on or before July 1, 2025 (the "July Prize"); and the second via a random drawing of all the eligible entries received on or before January 1, 2026 (the "January Prize"). Each winner can nominate an eligible rural or agricultural organization or food bank located within the Compeer lending service area (each a "Eligible Organization" and collectively, "Eligible Organizations") in their respective state to receive a \$1,500 donation. Winners must designate the donation go to an Eligible Organization in Compeer's lending service area in their state but may choose from all Eligible Organizations located within the Compeer lending service area within their state. In the event a nomination is chosen for an organization outside Compeer lending service area, such nomination will be null and void and a subsequent nomination chosen for an Eligible Organization.

WINNING: The prize winners (each, a "Prize Winner") will be selected in a random drawing, with one Prize Winner being chosen for each of the July Prize and the January Prize. Odds of winning a prize depend upon the total number of eligible entries received and are equal to one divided by the total number of valid entries received as of July 1, 2025 and January 1, 2026, respectively.
